

Biotech Dangers

In May, a team of engineers at Columbia announced a new implantable medical microchip, so tiny it can be injected into human body with a syringe. It's about the size of a single grain of salt. You can see the chip here being tested inside, yes, that's a raw chicken breast. So what exactly could an implantable device that miniscule actually do? The Columbia team hopes one day chips like these could detect the spread of cancers or monitor one tiny area of the body measuring the presence of a particular enzyme or biomarker. "

Professor: "In this particular paper, we were just measuring temperature, which is a relatively easy thing to measure in a solid state device, but you can imagine, uh, measuring all kinds of things."

Vice narrator: "Though the conspiracies may be frustrating, the team behind the injectable microchips say they won't let them get in the way of their progress."

(Professor) "I mean, we can delay publishing our stuff because we're worried that some crazy somewhere is gonna think that this is part of a conspiracy."

The scientists behind the microchip explain that it can *only* be connected to ultrasound and never wireless internet to debunk "conspiracy theorists," making it seem as if the idea of microchip vaccines is unfounded.

The article says that:

"the properties of recently studied nanomaterials, such as graphene, have inspired the concept of the Internet of NanoThings, based on the interconnection of nanoscale devices."

Graphene is being discussed as "an attractive material for the implementation of multifunctional brain implantable devises."

Graphene oxide is oxidized graphene that is soluble in water and is much cheaper than graphene; it can be mixed with polymers, nano, and other materials while still retaining some of the properties of graphene.

In June 2021, a group of Spanish scientists in a group called Quinta Columna detected graphene oxide in the aqueous suspension of a single vial of Pfizer's vaccine, which consists of six doses. In the future, they will attempt to analyze more samples, but it is conclusive that 98-99% graphene oxide is in this one sample, as verified by different detection methods against a standard.

It states that "this invention belongs to...the development of 2019-nCoV coronavirus nuclear recombinant nano-vaccine." Kingston claims that graphene oxide is not listed in the ingredients as a trade secret because it is a well-known toxin and is attached to the PEG (polyethylene glycol).

PEGs are conjugated with the lipid nanoparticles acting as the protective shell coating for the mRNA in the COVID-19 vaccines. (We will talk about the mRNA later.)

The use of PEGs as a drug delivery system is questionable given that there are "life-threatening side effects" in its use.

This article in February 2021 claims that "a specialized graphene oxide hydrogel can help stabilize therapeutic mRNA cancer vaccines...and that "before the pandemic both Moderna and BioNTech had a focus on developing cancer vaccines."

There is evidence to suggest that this hydrogel is part of the covid-19 vaccines.

Here is the Moderna patent for the vaccine, published in July 2020. In section 219 it discusses using "semi-conductive and metallic nanoparticles and then "gels and hydrogels"... saying, hydrogels are a network of polymer chains that are hydrophilic and sometimes found as a colloidal gel in which water is the dispersion medium...the hydrogel described herein may be used to encapsulate lipid nanoparticles..."

Dr. Violet: "Our next speaker is a hospitalist-physician assistant in New York and what what have you been seeing? What are they experiencing? What are they suffering from when they come in?"

Conrad: "People seem to have some underlying medical conditions and then they get their vaccine and then it makes them jump off a cliff, so to speak. So if somebody has, um, say they have, you know an underlying, maybe liver disorder, they drink or something like that and then they get their vaccine, all of a sudden they're liver enzymes will go crazy and they'll end up with with liver failure. Or if they have diabetes and they have a little bit of kidney impairment, they get their vaccine and all of a sudden they get hyperglycemia and they get kidney failure."

"We're seeing a lot of sepsis, that's one of the big things. It's like your immune system isn't working anymore and people are getting repeated episodes of sepsis. Women who have never had urinary tract infections in their life are coming in repeatedly in the hospital with sepsis and UTIs, I don't get it. These are young women.. and people will say that's coincidental, people get UTI's all the time. But not young women requiring hospitalization with bacteremia over and over and over again. It seems like these antibiotics don't work."

"We're seeing blood clots... uh... it's it's funny I just said the other day it seems like our our anticoagulants are no longer working suddenly in 2021. We're getting people coming in with pulmonary emboli and full anti-coagulation... It's crazy, we've been seeing that actually quite often."

"Strokes... um what we call um idiopathic strokes. We don't have any other cause and they're having strokes. Heart attacks, non-ischemic cardiomyopathy are big ones... We're getting cardiomyopathy which is just huge. Appendicitis... we're seeing over and over and over again in the hospital and especially immune system issues. People are coming in with new autoimmune conditions. We've had a couple of cases of mesenteritis, autoimmune mesenteritis. I've never seen that in my career. We had two gentlemen come in with acute AML, acute myeloid leukemia back to back one day apart. I mean we're we're seeing weird weird things and there's no there's no rhyme or reason. It could be it could be a couple of weeks after vaccination, it could be six weeks after vaccination, it could be months down the road."

Dr. Violet: "And this is all escalated since the vaccines were rolled out, it wasn't something you were seeing last year during covid?"

Conrad: "No absolutely not... and it's, it's hard because during covid our hospitals generally were empty. I mean people were afraid to come to the hospital, you know, except for obviously the covid people. So that kind of was the the reasoning we were all saying initially. We're like, oh well people were sick and they didn't seek health care so now they're coming with all their problems. Well, now we're well far from that, I mean we're going into September now and we're still seeing these issues. Our hospitals are full... I actually wrote four, two or four letters—actually four letters, I want to say, to the FDA and actually spoke with them back in March when all this started happening... and I kind of told them, we're seeing unprecedented amounts of patients in the hospital with problems, can you please tell me what am I seeing, what am I supposed to be doing, who do I report to, how far out do I report and I heard nothing back. And nobody's helping these vaccinated people who are potentially injured, nobody. They're calling them crazy, that they need psychiatric care, that they have anxiety that that it's coincidental but what if it's not?"

News: There is big news on the vaccine front. Today the FDA granted full approval for the Pfizer Code Vaccine for people sixteen and up. It had been approved for emergency use since December but now this means more places can start mandating that people get it.

News: President Joe Biden used the announcement to argue for more vaccine requirements. Biden: If your a business leader, a nonprofit leader, a state or local leader, who has been waiting for full FDA approval to require vaccinations I call on you now to do that, require it. Reporter: The pentagon was quick to follow the president's lead. Pentagon: The department is prepared to issue updated guidance requiring all service members to be vaccinated.

Those who think government regulations are the solution to vaccine problems and injuries don't know that government has been in bed with the vaccine industry since its inception in military bioweapons labs like Ft. Detrick... all the way to legal mandates... as a eugenics operation.

Autism and the MMR Vaccine

Reporter: "It's a daily struggle for his parents to simply reach their son who they've lost to autism."

Father: "He's just uh, he just sits, just sits there or spins around and just not communicating at all. He's like a zombie."

Reporter: "The difference is startling. Flore and Grant Hume say this home video of her son shows a bubbly toddler developing normally."

Flore: "Ah, he's the most interactive little boy."

Grant: "He was so playful, yeah. he was always running around running up to you hugging you."

Flore: "Within two weeks of the MMR injection he, he had such a profound change of his personality."

Grant: "Language use, couldn't use, his speech really dropped off."

Reporter: "There are thousands of parents who are all saying the same thing, that the triple vaccine MMR is to blame for their children's autism. Both Terry and his older brother Michael have been diagnosed with high functioning autism. Their parents, Isabel and Ian Thomas haven't had a good sleep in a long time. It's like this day and night."

Isabel: "Sit down to eat, Michael."

Reporter: "But again their parents say as toddlers they were developing normally."

Isabel: "When Terry was walking when he was ten months old, Michael was talking fluently at the age of two."

Autism or autism spectrum disorder is a group of neurological disorders that cause impaired communication and speech, challenges in social skills, and restrictive and repetitive behaviors.

Before the mass vaccination program on infants and children, there was a 1 in 10,000 chance of getting autism; today 1 in 36 children will get autism.

One of the most publicized vaccine cover-ups has been concealing the link between the MMR (measles-mumps-rubella) vaccine and autism.

The MMR vaccine contains the attenuated (weakened) live measles, mumps, and rubella viruses.

In 1998, Dr. Vijendra Singh with the University of Michigan co-authored a paper reporting the presence of viral antibodies in autistic children. These antibodies attack the brain by targeting the basic building blocks of myelin, the insulating sheath that covers nerve fibers. Singh hypothesized that this autoimmune response may be the cause of autism.

In 2002, Singh and others reported that 75 out of 125 autistic children had measles-mumps-rubella antibodies suggesting "a strong association between MMR and CNS autoimmunity in autism."

This connects with our discussion in Part 9, where we looked at the connection between demyelinating disease and vaccine autoimmune response, including polio, atypical polio, chronic

fatigue syndrome, multiple sclerosis, fibromyalgia, and guillian-barre.

In 1993, British surgeon and gastroenterologist Dr. Andrew Wakefield and others found measles virus RNA in the intestinal tissues of those with Crohn's disease, an inflammatory bowel disease.

Wakefield had later discovered that children with autism had mild to moderate inflammation of the lymph glands in the intestinal lining, predominately small intestines, which he would later call *autistic enterocolitis* to differentiate it from other gastrointestinal illnesses.

In 1998, Wakefield and others published a paper in Lancet assessing and profiling 12 of his patients with this pattern of symptoms. He concluded that "the consequences of an inflamed or dysfunctional intestine may play a part in behavioral changes in some children."

While this paper did not show an empirical connection between the MMR vaccine and autism, Wakefield did mention that 8 parents of his 12 patients informed him that the onset of developmental and gastrointestinal symptoms occurred post MMR vaccination.

In that 1998 paper, Wakefield provided other research that showed the likeliness of a link, such as the work of Sudhir Gupta.

Nonetheless, the 1998 Lancet paper was so controversial, Wakefield was asked to leave the Royal Free Hospital where he worked; so in 2001 he came to the U.S. to continue his research to empirically verify the potential link between the MMR vaccine and autism.

In 2000 and 2001, Wakefield and others published papers revealing the detection of the vaccine-strain measles virus in patients with autism and inflammatory bowel disease.

In this paper, the data confirmed "an association between the presence of measles virus and gut pathology in children with developmental disorder."

In 2010, Wakefield's Lancet article was retracted and he was banned from medical practice in the UK. His reputation was slandered by journalist Brian Deer from the British Medical Journal. There was certainly a conflict of interest as the British Medical Journal had signed a partnership in 2008 with Merck, the inventor of the MMR vaccine.

Bigtree: "In pursuit of following the story by Doctor William Thompson I met Doctor Andrew Wakefield who was the one who was already making a documentary about Thompson, the CDC whistleblower. I had to make sure that it wasn't just aligning myself with with someone that was the fraud that they said he was. And in that investigation of Andy looking into the story about the Lancet paper in the original statements that he'd made about the MMR Vaccine and it's potential cause or a causal relationship to autism. I mean mean the story falls apart immediately. The story I heard through the press, the story that we sort of repeated in medical journalism over and over again just fell apart before my eyes simply reading the Lancet paper."

VAXXED is about Dr. William Thompson, senior scientist at the CDC and co-author of many vaccine safety studies, Thompson contacted Brian Hooker, a CDC critic and parent of an autistic child, who Brian claims developed autism after the MMR shot. In over 40 phone conversations, some of which Hooker secretly recorded, legally in the state of Oregon, Thompson confessed to the fraudulent activities of the CDC, deliberately covering-up and altering data.

Two particular studies showed that the MMR vaccine causes autism in those with "isolated autism" cases, and is particularly susceptible to African Americans boys but the data was omitted to claim there was no link or increased incidence.

In the decades that followed, the evidence against thimerosal continued to mount. During the Second World War, when the Department of Defense used the preservative in vaccines on soldiers, it required Lilly to label it "poison." In 1967, a study in Applied Microbiology found that thimerosal killed mice when added to injected vaccines. Four years later, Lilly's own studies discerned that thimerosal was "toxic to tissue cells" in concentrations as low as one part per million — 100 times weaker than the concentration in a typical vaccine. Even so, the company continued to promote thimerosal as "nontoxic" and also incorporated it into topical disinfectants. In 1977, ten babies at a Toronto hospital died when an antiseptic preserved with thimerosal was dabbed onto their umbilical cords.

In 1982, the FDA proposed a ban on over-the-counter products that contained thimerosal, and in 1991 the agency considered banning it from animal vaccines. But tragically, that same year, the CDC recommended that infants be injected with a series of mercury-laced vaccines. Newborns would be vaccinated for hepatitis B within twenty-four hours of birth, and two-month-old infants would be immunized for Haemophilus influenza B and diphtheria-tetanus-pertussis.

Since 1991...the estimated number of cases of autism had increased fifteen-fold, from one in every 2,500 children to one in 166 children.

...In China, where the disease was virtually unknown prior to the introduction of thimerosal by U.S. drug manufacturers in 1999, news reports indicate that there are now more than 1.8 million autistics."

Geier: There are hundreds maybe thousands of studies from the early nineteen thirties through the present that have called into question the use of thimerosal on every single kind of product. And a particular interesting one was in 1948, there were so many complaints, that the AMA the American Medical Association put together a blue ribbon panel to study what they should do and recommend about all these complaints they were published in the literature and Frank Engley was on that committee who is still alive today and maybe you get to talk to him and may have seen him."

Frank Engley, PhD (retired Chairman, Dept. of Microbiology of University of Missouri): "We found out that the thimerosal would be toxic down to not grams, not milligrams, not micrograms, but nanograms, parts per billion which is almost unbelievable. This was published in the American Journal Medical Society in the New York Academy Sciences and in the Journal for the Chemical Specialists

Manufacturers Association and it didn't make a wave. There wasn't a ripple. No one seemed to care."

"You couldn't even construct a study that shows thimerosal is safe," says Haley, who heads the chemistry department at the University of Kentucky. "It's just too darn toxic. If you inject thimerosal into an animal, its brain will sicken. If you apply it to living tissue, the cells die. If you put it in a petri dish, the culture dies. Knowing these things, it would be shocking if one could inject it into an infant without causing damage."

While 2ppb limit of mercury is allowed in water which is too much, there was 25,000 ppb of mercury in the hepatitis B shot given to newborns. Aluminum is also in the hepatitis A, Diphtheria-tetanus (Dtap, Tdap), HPV (human papalloma virus), pneumococcal, and meninogococcal B vaccines and more.

In 2010, a report was published by the Harvard Pilgrim Health Care Institution titled: *Electronic Support for Public Health-Vaccine Adverse Event Reporting System (ESP:VAERS)* with the intention of improving the safety of vaccination programs by improving the reporting of adverse reactions. They found that "adverse events from drugs and vaccine are common, but underreported," and that "fewer than 1% of vaccine adverse events are reported."

evaluation.

The VAERS system is mostly kept a secret; most people don't link vaccine injuries to vaccinations because of the indoctrination that vaccines could never cause harm. If a person gets a vaccine against influenza and gets a heart stroke the next day, he and his doctors will consider the vaccine unrelated and successful as he did not get influenza the next day.

And this is still the case for the majority of medical professionals today who are at the front line patient care."

"I knew nothing about vaccine manufacture, contents, risks, or history. After being handed the schedule of vaccines for kids during my pediatric rotations, I was told to give them on time and that was the extent of my knowledge... As a nephrologist, I gave hepatitis B vaccines to dialysis patients. Their immune systems don't respond very well, so we often had to give them numerous injections of high dose aluminum vaccines, which is an enormous aluminum load. I gave flu shots, pneumonia shots, all per dialysis protocol, never considering any potential problems. Nothing was linked to vaccines in my mind, until one patient in 2009 volunteered to me, "I was fine until I had that flu shot," and I thought well that can't be. But the other doctors and I could find no alternative cause... Until 2009, I had never once considered vaccines as a potential threat to kidney health."

"This was my sentinel case, a man who had normal kidneys documented by blood work prior to December then was vaccinated in his doctor's office and came to the hospital and renal shutdown two

weeks later. He required dialysis for about three weeks and then was taken off of dialysis but as kidney function only returned to about seventy percent. I want to show you a sampling of some other cases that I made record of after that first eye opening event when I began to ask a simple question when was your last vaccine?" (skipping ahead)

"In 2001, I was idealistic and naive. I thought those involved in policy-making, especially the ones whom I knew for years, would want to do what is best for patients over and above what policy dictated. How wrong I was. The hospital policy was to vaccinate as many patients as possible on the first hospital day... And I decided to speak to the hospital management about what I was seeing. One day in the corridor, I bumped into the Chief of Medicine. He asked me how things were going and I detailed my concerns to him, and according to him I was the only doctor seeing these problems. There must be studies on the subject and writings in the medical literature in order for these doctors to be so sure of the rightness of their policy... After all, it's science we're talking about, isn't it? I submitted a written report to the administration. In my research, I found that aluminum in vaccines is a documented cause of granuloma formation, something I've been familiar with for years."

Moreover, I found that my patient population with acute and chronic illness had barely been tested for vaccine efficacy, safety, or long term consequences. So the answer of course is no, patients cannot be assured of safety."

"Some documented ill effects of vaccines upon kidneys include autoimmune kidney disease, vasculitis, thrombotic thrombocytopenic purpura, and aluminum mediated granuloma issues... So I discussed all this evidence for over a year with the administration and with my various colleagues. Other doctors were starting to change their previously set minds and a high number of nurses were catching on. But then because the hospital administration could not rebut my arguments, they called upon an expert to set me straight. He never addressed any of my questions regarding acute kidney patients or acutely ill new admissions."

"The executive committee of my hospital also told me that it was not appropriate for me to stop vaccination orders on my patients and that I was confusing the nursing staff. I thought how bizarre, nurses are never used to the same treatment plan for all patients ever. My experience was not one of confusing nurses at all but of finding other vaccination critical people on the hospital staff who agreed with me. After I left the hospital, this article by Duggal came out, as have several others, which implicate flu shots in the genesis of autoimmune and vascular diseases... And just last month I got a note from a woman whose spouse with kidney disease who was very stable died at home one day after receiving two vaccines. She was extremely distressed and I had no comforting words for her. Since leaving the hospital in 2011, more literature has been published besides Duggal that supports my hypothesis and my experience that common and difficult to treat kidney diseases can be caused and worsened by vaccine ingredients."

Now, some doctors who have not let their beliefs bias their perceptions have keenly observed marked differences between vaccinated and unvaccinated individuals.

Take for example, what Thomas Cowan, doctor of a San Francisco clinic saw, relayed in his book *Vaccines, Autoimmunity, and the Changing Nature of Childhood Illness*, 2018:

"I rarely saw an unvaccinated child in my practice with a chronic illness or any sort. In general, these children ate healthy diets, played outside a lot, and were in good health. However, among the patients who were partially or fully vaccinated because they had seen other physicians or pediatricians in the past, I treated many who had one or more chronic health conditions, including asthma, eczema, seizures, and digestive disorders. As time went on, all of these disorders become more common among the partially or fully vaccinated children I saw. I believe this corresponded with the introduction in the late 1980s to the mid-1990s of certain adjuvants and excipients, as well as the introduction of

ever more vaccines."

My New Hampshire practice also afforded me the opportunity to treat some of the illnesses for which most children are routinely vaccinated. I have seen hundreds of cases of whooping cough (including my three children); hundreds of cases of chicken pox; approximately fifty cases of measles; one case of tetanus; about twenty cases of mumps; a few cases of German measles; no diphtheria; no meningitis; no cases of paralytic polio; and no new onset cases of hepatitis B. Two children in my care were hospitalized as a result of these illnesses: one from complications of chickenpox and one for tetanus. As far as I know, all of the children, including the two who were hospitalized, emerged alive and well, with no long-term complications as a result of their illness."

A few decades later, not only is it common for families to have at least one member who's being treated for a chronic illness, but also autism, learning disabilities, asthma, and food allergies have exploded in their frequency and severity. For example, approximately; 1 in 2.5 children has an allergy, 1 in 6 children has a developmental disability, 1 in 9 children has attention-deficit/hyperactivity disorder (ADHD), 1 in 11 children has asthma, 1 in 13 children has severe food allergies, 1 in 36 his autism.

These numbers represent a national emergency." (p.14)

This brings us to the question:

Have there been studies comparing the general health outcome between the vaccinated and unvaccinated? While this has been requested to Congress, it has never been done and the CDC refuses to ever do such a study.

Dr. Lawrence Palevsky: Now as a medical doctor who was taught to think I then went into the literature and said are are proper science studies done, safety studies where you take a vaccine and you injected into a hundred kids and then you give a hundred kids a saline placebo, meaning it's inert. No study exists to actually evaluate the safety of a vaccine compared to a placebo group. None.

Despite public health authorities refusing this study, several independent studies have been done comparing the vaccinated with the unvaccinated.

This 2000 study: Routine Vaccinations and Child Survival: Follow up Study in Guinea-Bissau, West Africa found that the death rate was twice as high in the vaccinated children against diphtheria. tetanus, and whooping cough as the unvaccinated.

In 2017, the Journal of Translational Science published a Pilot comparative study on the health of vaccinated and unvaccinated 6-to12-year-old U.S. Children comparing 261 unvaccinated with 405 partially or fully vaccinated.

The results showed an increased risk of many diagnoses among the vaccinated children including allergic rhinitis (30.1), learning disabilities (5.2), attention deficit hyperactivity disorder (ADHD) (4.2), autism (4.2), neurodevelopmental disorders (3.7), eczema (2.9), and chronic illness (2.4). The increased risk of neurodevelopmental disorders appeared to be higher in cases of preterm births.

Vaccinated children were 340% more likely to be diagnosed with Attention Deficit Hyperactivity Disorder than unvaccinated children!!

In May 2020, Brian Hooker and Neil Miller found that vaccinated children had an increase in odds ratio in developmental delay, asthma, and ear infection compared to unvaccinated children in a study using three practices.

In November 2020, Dr. Paul Thomas, owner of a pediatric practice in Oregon teamed up with an expert in experimental design, research scientist James Lyons-Weiler, to perform a comparison study (above) in Dr. Thomas' own clinic with children who have been with him since the beginning of their life. The study was on 3,324 pediatric patients of D. Thomas exclusively for a 10 year period in which 2,763 received at least one vaccine and 561 children did not receive *any* vaccines. They compared the number of doctors visits with three groups, the unvaccinated, the vaccinated, and the partially vaccinated.

They write:

We have found higher rates of office visits and diagnoses of common chronic ailments in the most vaccinated children in the practice compared to children who are completely unvaccinated. The data clearly show different odds of developing many of these adverse health conditions.

The data revealed that even those partially vaccinated were more sick than unvaccinated children.

Dr. Thomas: "Look at what the data shows, I think for your viewers probably put this image up."

Spiro: "Yes absolutely."

Dr. Thomas: "Yeah so this is like sort of a key graph visually. You see in the orange lines which are the ones that kind of skyrocket are the various conditions that... those are the vaccinated kids, terribly vaccinated children and the blue line are the unvaccinated children, and then the timeline is is over those ten years, and as your vaccine uptake increases. And you just see dramatic increases in asthma, allergies, breathing, problems behavioral issues, ADD/ADHD, respiratory infections, other infections like ear infections, eye infections, eye disorders, the skin disorder like eczema which we think of as allergic, dermatitis, urticaria (itchy rash) and anemia was a surprise finding. And you can see it just skyrockets at one point in time. Well that's because in pediatrics we checked for anemia at nine months, it's just standard. And I was shocked to see that the unvaccinated pretty much [had nothing], I mean a little tiny blip of anemia. It's the vaccines, period. I mean there it is. So we've got theories for that and that might be another paper. But we can no longer say [it's not the vaccines] with the significance of this data, it's a large enough sample size to have [certainty]... Jack Lyons-Weiler, who helped with a lot of the analysis, he doesn't even like P values, [says] ah that's junk. Yeah, I'm an

old school statistics [guy], into the simple stuff, and I said, well do the P values. I want to see them, right. And, uh they're off the charts! You know, most studies are published with a P value point zero one and you go, whoa that's so significant. And we have P values of point zero zero zero zero one! That kind of thing, where its like there's no way this is by chance. So I think we have answered the question, at least in my practice if you do things the way I do them in my practice, vaccines clearly cause harm and not vaccinating or vaccinating less clearly has health benefits."

Because of this study, the Oregon state revoked Dr. Thomas' medical license and a book has been written about the subject.

What does the CDC mean by "safe and effective"?

In this presentation, Dr. Sheri Tenpenny discusses how safety studies are not properly done from her research on vaccines beginning in 2000.

Tenpenny: "Well, how the heck did I get into, interested in vaccinations? Because who I am is is a classically trained physician. I'm board certified in emergency medicine. I practice in emergency department for twelve years and not only was I an emergency room physician, I was the director of the ER, the President of our ER corporation, and I ran a three county EMS, and I set up a three county mental health transportation system that involved the sheriff's department, the police department, and the state highway patrol. So not only did I do every conventional thing that you can imagine in terms of conventional medicine, but when I was an ER doc, I used to hand out tetanus shots like they were some special form a candy."

"Well it was in September of 2000, I had the opportunity to attend the National Vaccine Information Center meeting in Washington DC. And at that point, I went in and I sat for four days listening to a meeting and I just couldn't even believe my ears. I mean I'm rather an information junkie and I read a lot and I study a lot and this whole area of medicine was totally new to me. How did I miss this? Well it just became such a fascination for me because I thought, well if all these people standing up here with big credentials and really seem to be very knowledgeable are speaking out against vaccines may maybe that's something that I ought to take a look at. So figuring that the best defense is a good offense, I thought that best place to start was to go to the CDC. Now the CDC is the Center for Disease Control, and they are what we call the highest law in the land when it comes to vaccines... So when I started going to the CDC Documents, I decided that I didn't really have to look many other places because there was so much information in there that it was not known to doctors, not known to the general public, and really showed that vaccines did cause a lot of damage and that there was a real reason for concern... So after about the last three years of just spending all of my extra time, I mean my friends who know me say know you have no life because I spend all my evenings reading CDC documents and so I do that because I'm very passionate about this topic. I believe that we really need to know more about this; I'm very passionate about the vaccine injured children that we treat our clinic; and I'm very passionate to do something to get the information out to stop the tide of what's happening in this country in terms of vaccine injury."

She informs us that their safety studies do not use double blind placebo controls (which would be testing the vaccine against a saline solution), but they merely compare one vaccine to another vaccine or to the vaccine adjuvant. They only use healthy people—and yet recommend or mandate the vaccine to be administered to the sick or immuno-compromised; and data can easily be changed or eliminated if the investigator wants to (this is discussed at 14 minutes).

Tenpenny: "Serious side effects can be negated simply with the stroke of a pen. And here's two examples that I'm going to read some to you, a little bit out of a study, because I think that this makes a very big important point, is that when safety studies are designed if the conclusions are not in line with what they-- if there's any data that's not in line with the conclusions, then what ends up happening is that it's just negated. So here's a study that they used, 882 healthy infants, there's that healthy infant part again, to compare Combax, a new vaccine that had the hib and the hepatitis B in it, they gave them to some and then the other ones they gave the hib and the hepatitis B in two separate shots. So they're comparing a new combination vaccine in one vile compared to two separate shots. That's what's considered the design of the safety study. As they go through this, during the study there were 17 children, or nearly two percent that had events within fourteen days of vaccination that met defining criteria of a serious adverse experience. These included seizure, diarrhea, vomiting, dehydration, bronchiolitis, tachypnea, which is really rapid breathing, pneumonia, reflux esophagitis, and vitreous hemorrhage, which is bleeding in the back of the eye. Virtually all of these experiences were classified as serious because they involved hospitalization. None was judged by the study investigators to be caused by the vaccine."

Trials are usually done for just a few days as there are no long-term studies of effects.

Most vaccine safety studies are performed by the vaccine company itself. While the CDC does some studies, it is also biased towards approval as the CDC is a vaccine company, having over 20 vaccine patents and selling about \$4.6 billion vaccines per year.

As a side note, 50% of the EPA's funding also comes from vaccines.

Dr. Tenpenny exposes how the CDC goes so far to blatantly state that any adverse reactions that occur after taking a vaccine are caused by either another illness and/or a genetic defects of the child. (1:10 hr. mark).

Tenpenny: "Now what does the CDC say about all these reactions? I mean we've talked about all the side effects, all those stuff with the hepatitis B and the side effects of the chicken pox vaccine. What do they really say in their literature about this? This is a mantra that you hear over and over again: 'temporal association does not prove causality.' And what that means, in plain language, is that when two things happen at the same time you can't prove that one caused the other... So what if you have a really bad reaction because we know that this happens. I mean we even set up the National Vaccine Injury Compensation Program where people are supposed to be able to go and get money, if they have a vaccine injury. Who are we supposed to blame for this? Well... it's not the vaccine because we write all those things out, it can't be that, and it's really not the doctor because the doctor through the Vaccine Injury Compensation Program is absconded from liability. And the manufacture can't be sued because of the Vaccine Injury Compensation Act. And the government isn't responsible because they don't--you can't sue the government anyways. We'd all like to, but you really can't. So what happens? Well, in conventional thinking, the way conventional medical doctors think about this is that the vaccine injury must have triggered, summoned that inevitable thing that happened and that these children had some sort of a weakness that was manifest--would have been manifested in this way at this point with or without the vaccine. So who takes the hit? The genetically defective child... This actually comes from the CDC: 'that there is no distinct syndrome from vaccine administration and therefore many temporally associated adverse events probably represent background illness rather than illness caused by the

vaccine."

Here is a statement by the CDC to push plausible deniability when the illnesses that the vaccine was designed to prevent occur.

Dr. Tenpenny discusses how there is a conflation between the terms vaccination and immunization, as they are not the same. "Research efficacy" and "clinical efficacy" are also conflated in the same way. Vaccination and research efficacy mean that the vaccine created an immune response (through antibody detection), whereas immunization and clinical efficacy means that one has immunity towards a disease. These terms are deliberated confused so that people think that vaccination means that you are immune to a future disease.

In order to validate the latter (immunization), one would have to do studies exposing test subjects to the wild virus post-vaccination. This is rarely done but in very few animal studies that are extremely short term term.

Nonetheless, an immune response from a vaccine is considered to make that vaccine effective against disease when an immune response can be deadly. But many studies will flat out admit that the vaccine doesn't provide protection against a disease (Dr. Tenpenny discusses at 20-25 minutes).

Tenpenny: "And what about smallpox? And this came from a JAMA article back in 1999, and it said that neutralizing antibodies are reported to reflect levels of protection although this has not been validated in the field. So you can get antibodies but we really don't know if this is going to protect you or not."

"And this came from a research interview from Dr. John March from the Morton Research Institute in Scotland where they do a lot of investigation and animal studies, primarily with vaccines and animals. And what he said in that in that interview was 'particularly for viral diseases, the cellular immune responses is all important; Antibody levels and protection are TOTALLY UNCONNECTED.' So this is something that we kind of know, but it's not anything that we put into practice. We really do believe that 'effective' means 'clinical protection' and those two things just like vaccination and immunization aren't synonyms, neither are vaccination and antibody production synonymous with protection."

By the age of six, following the CDC schedule, children will have 49 doses of 14 vaccines starting on the day of birth. A child can receive more than eight vaccines in one visit. There are no safety studies on multiple vaccine injections, whether that be in one day or over the course of years.

According to a 2013 report by the Institute of Medicine:

"... the concept of the immunization schedule is not well developed in the scientific literature... Key elements of the immunization schedule—for example, the number, frequency, timing, order, and age at the time of administration of vaccines—have not been systematically examined in research studies." https://www.ncbi.nlm.nih.gov/books/NBK206948/pdf/Bookshelf_NBK206948.pdf

Now in 2009, the Kobe University of Japan vaccinated different animals with multiple vaccines (not using toxic adjuvants but just the viral antigens) and found that:

"Systemic autoimmunity appears to be the inevitable consequence of over-stimulating the host's immune system by repeated immunization with antigen, to the levels that surpass system's self-organize criticality."

When a person is put on new medication, he is usually monitored by a doctor, but with vaccines that admittedly have toxic substances, there is no follow-up to see if the body recovered from the infection or if all the toxins were purged from the body or if an autoimmune response has occurred; the vaccination is completely ignored as a contributing factor for any future medical issue.

We just keep adding vaccines to the list as Big Pharma propagandist Paul Offit claims that children could be safely injected with 10,000 vaccines in his book *Deadly Choices*.

In previous parts of this series we have learned that viruses adapt and combine to make more virulent strains as performed by gain-of-function studies and serial passaging.

Dr. Tenpenny (near the 1:30 hr. mark) discusses a 1986 animal experiment that revealed how combining viruses can create more virulent recombinants through the act of vaccination. (I couldn't find the original study.)

Dr. Tenpenny: "The known physiological effects of vaccines is that viruses can lay dormant. They can be latent and there's a process called transcession, in which one virus can marry another virus, and then they can be combined and be totally something different. And this is what actually happened. This is a really great study. I'm going to walk you through here ... that a hundred part - - that this was done, it was a mouse study and they use viruses in mice. They used a hundred particles of a benign herpes virus and they put it into the first mouse and nothing happened. The mouse was just fine. They took a hundred particles of a second type of virus, virus B, and they put it into a second mouse, nothing happened. The mouse was fine. They took one particle of each of these, one unit particle of each of those, put it into the third mouse. The mouse dies. And not only that, when they did the autopsies on the mice, they found eleven new recombinant types of viruses and three were lethal to the next generation. Though if we could get totally pure measles, mumps and rubella that was nothing more than absolutely the measles virus, and absolutely just mumps, and absolutely just rubella, and absolutely just chicken pox, we're still combining four viruses together, one that when kids go in and get MMR and chicken pox. But we know just from the little science stuff that we just went through how they create these vaccines is by using these different avian serum and bovine serum, all these things... so what are we creating is kind of like we don't know."

"And the conclusion of this study was that two avirulent viruses, two benign viruses, they interact in vivo which means in living tissue to come to produce virulent combinations that can be lethal. This came from Science magazine 1986."

Many studies have shown that vaccination produces more virulent strains of pathogens. Injecting viruses into a living being should be seen as an *in vivo* experiment as viruses can mutate and adapt to the cells and proteins in the body in unpredictable ways; thus it should be no surprise that vaccines are "pushing pathogens to evolve."


Interviewer: "How do you view the mass vaccination program?"

Reporter: "So very very interesting. Here pretty much visual form shows, fairly obviously, that vaccines are directly related to the number of variants there are.
